## Did You Know?

A "Did You Know" section will be featured regularly in an effort to inform and educate employees of policies, procedures or news of importance.

Texas Panhandle Centers may grant up to twelve (12) weeks, or one (1) academic semester of unpaid leave of absence during any twelve (12) month (one year) period to eligible employees in accordance with TPC Personnel Policies and Procedures and the Family and Medical Leave Act of 1993. If ever a conflict in interpretation should occur between these policies and the Family and Medical Leave Act of 1993, the Act shall prevail.

Employees shall not be eligible to accrue PTO during the period the employee is on full-time leave or part-time leave of absence.

Employees shall not accrue any PTO during a pay period if they worked less than eighty hours in the pay period.

Employees who take a leave of absence without pay for educational purposes must agree to continue their employment with TPC for a period of at least two (2) years, or repay TPC the cost of all premiums for health and dental coverage provided during their leave of absence without pay.

## **Medicaid Managed Care**

Effective March 1, Medicaid managed care expanded across Texas in an attempt to control Medicaid expenses for approximately 3 million current Texans. Texas is growing very rapidly (now 27 million residents), and with that growth comes additional Medicaid recipients. The Texas Legislature is requiring the Texas Health & Human Services Commission to contract with private managed care companies on a capitated basis, which means that those companies will contract for a set amount of money each year and their Medicaid expenses must be less than the contracted amount for them to make a profit.

The STAR managed care initiative began in five Panhandle counties (Potter, Randall, Deaf Smith, Carson and Hutchinson) in September, 2011 and it is those same counties that converted to STAR+PLUS in March, a similar initiative but with a larger group of Medicaid recipients. Also in March, Medicaid recipients residing in our other 16 counties were required to participate in STAR.



Good Housekeeping provides a quick and easy tip for cleaning household ceiling fans.

Tools: Old table cloth or sheet, extendable duster or step stool, Micro-fiber cloth

To get rid of the grime that all ceiling fans seem to collect (created by dust clinging to greasy airborne particles), place an old fabric tablecloth or sheet underneath the fan; a shower cap to protect your hair from debris



also isn't a bad idea. With an extendable duster, go over the tops and bottoms of the blades to capture loose dust. Or just grab a step stool, and dust with a dry micro-fiber cloth on both sides of blades. Shake out the cloth, lightly dampen it; wipe blades again, this time picking up any oily film. Give glass fixtures a pass with a clean section of cloth while you're up there.

### IRISH CREAM CHEESE SUGAR COOKIES



Ingredients:

1 cup white sugar 1 cup butter, softened 1 (3 oz.) package cream cheese, softened 1/2 teaspoon salt 1/2 teaspoon almond extract 1/2 teaspoon vanilla extract 1 egg yolk

2 1/4 cups all-purpose flour

#### Directions:

 In a large bowl, combine the sugar, butter, cream cheese, salt, almond and vanilla extracts and egg yolk. Beat until smooth. Stir in flour until well blended. Chill the dough for 8 hours or overnight.

- 2. Preheat oven to 375 degrees.
- On a lightly floured surface roll dough 1/3 at a time to 1/8 inch thickness, refrigerating remaining dough until ready to use. Cut into desired shapes with lightly floured cookie cutters. Place 1 inch apart on ungreased cookie sheets.
- 4. Bake 7 to 10 minutes or until light golden brown. Cool completely before frosting.

## **Keep Critical Documents Safe and Accessible**

In case of fire or an immediate evacuation order, could you quickly find all of your important documents? If you're like most people, your birth certificate, marriage license, insurance papers, mortgage and retirement fund information are in

several different places.

Not only could this cause problems for you in an emergency, if they are needed by your family at a difficult time, their search could be difficult and frustrating. The best way to store critical documents is to keep them in a fire proof cabinet or safe.

Divide them into categories and mark each one clearly in case your family has to locate them on your behalf. Include:

- Key contacts: phone numbers, addresses for family members, banks, life, home and auto insurance providers.
- Identification documents: birth certificate, adoption papers, a copy of your drivers license, Social Security card, marriage li-

cense or civil union certificates.

• Emergency information: whatever would be needed if you became seriously ill or

injured, such as living wills, care proxies, beneficiary forms, IRAs, 401(k)s, last will and testament, burial instructions, cemetery plot and deeds or prepaid cremation documents, and military discharge papers.

- Insurance policies: life insurance policies and documents, health and accident ID cards and claim records, mortgage insurance policies, annuity statements, beneficiary forms and any long term care policies.
- Financial paperwork: checks, bank statements, mortgages, auto and other loan information, credit card statements, appraisals of valuable items, rental or lease agreements, investments, real estate deeds or titles of ownership and last year's tax returns.

It is a good idea to review the information with those who would need to access to it.

### Moneywise...

#### **CREDIT SCORE BENEFITS**

The maximum FICO credit score is 850, but only 18 percent of FICO's 200 million consumers were rated 800 or higher in 2011. People with a score of 780 may search for ways to get a higher number. It's the new status symbol.

If you have a credit score between 620 and 690, there are big benefits in doing all you can to increase it, such as paying bills on time and reducing debt to keep your ratio of debt-to-credit limit at 30 percent or less. Anything under 30 percent is a very good debt-to-credit limit ratio.

With each 10 points your FICO score increases between 620 and 690, you get better loan and mortgage interest rates,

and lower car insurance premiums.

When your credit score reaches 750 to 760, there are fewer benefits to making it any higher, because you are assumed to be a good credit risk. The national median credit score is 711.

The Fair Credit Reporting Act (FCRA) requires credit bureaus to provide you with a free copy of your credit report, at your request, once every 12 months. There are three nationwide consumer reporting companies: Equifax, Experian, and Trans Union.
